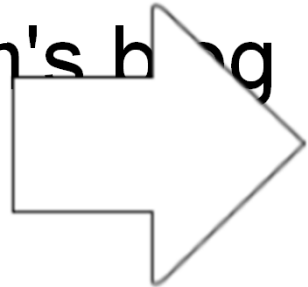
# Refeeding/Repurposing Information
